- Family Law Section: The Section meets monthly over lunch to provide continuing legal education to family lawyers, and to work on programs that assist family lawyers and litigants in obtaining high quality service and access to justice in Colorado domestic relations and juvenile Courts. The Section encourages attorneys to provide more access to unbundled legal services, works on projects to educate family court judges, works to make positive changes in Colorado family law, donates funds to organizations providing help to lower income family law litigants, and many other activities to improve the practice of family law in Colorado.
